# **GENERAL INFORMATION**

#### **JURY**

All Design and Student Award Category submittals will be reviewed by a 5 -7 member Jury selected by the Awards Committee. The Members will be comprised of Landscape Architecture and related design professionals with a broad understanding of public, private, and academic practice and exemplify a diversity in professional experience. The Jury process is "blind", in other words, the identity of the entrant and the project team is not revealed to the Jury Members.

Special Awards will be reviewed and awarded by the Hawaii Chapter Executive Committee.

#### **AWARD DESCRIPTIONS**

<u>Award of Excellence:</u> One Award may be awarded in each category if determined by a unanimous vote of the Jurors.

<u>Honor Award:</u> One Award may be given in each category for the most outstanding projects. The Award will be given by majority vote and not necessarily by full consensus.

Merit Award: Any number of Awards may be given in each category to recognize superior accomplishment. The Award will be given by majority vote and not necessarily by full consensus.

WINNING ENTRANTS will be announced and receive Award Certificates at the Awards Gala to be held at the Pacific Club, Honolulu, Hawaii on Thursday, September 26<sup>th</sup>, 5:00 p.m. to 9:00 p.m.

#### **ELIGIBILITY**

Any individual, firm, agency, student, or academic institution are eligible to submit a project as long as one of the primary participants is an ASLA Hawaii Chapter member.

<u>Professional Award Categories</u> must be an ASLA Hawaii Chapter Fellow, Full or Associate member or able to join ASLA Hawaii in one of those membership categories.

Student General Award Category must be currently enrolled in a Landscape Architecture Program AND be an SCASLA Hawaii Chapter member OR be a 1<sup>st</sup> year Associate Hawaii Chapter member.

Non-members must join ASLA Hawaii Chapter prior to entering the Awards program. Please allow 72 hours to process your membership. Student membership is FREE! Join at ASLA website https://www.asla.org/Membership.aspx.

Entry projects must not have previously won an ASLA Hawaii Award.

Project locations may be international, nationwide, and the state of Hawaii, but work must be completed by an ASLA Hawaii Chapter member.

# GENERAL DESIGN (PUBLIC AND PRIVATE)

Entries in this category must be built.

Recognizes construction of site-specific works of landscape architectural design. For large incremental projects at least the first phase must be constructed to be eligible.

**AWARD CATEGORIES** 

Typical entries may include public and private landscapes of all kinds. Projects may include communities and housing, urban design, streetscapes and public spaces, parks and recreational facilities, transportation corridors and facilities, historic preservation and restoration, commercial facilities, green roofs, resorts, institutions and campus design, storm water management, restoration, reclamation, and conservation, landscape art and earth sculpture, interior landscapes, and more.

- 4. Environmental sensitivity and sustainability
- Design value to the client, community, and other designers.

# **AWARD CATEGORIES**

#### RESIDENTIAL DESIGN (SINGLE-FAMILY)

Entries in this category must be built. Recognizes construction of sitespecific works of single-family residential projects consisting of one or more dwelling units on a single lot.

Typical entries may include single family homes new construction or renovations; historic preservation, restoration, or rehabilitation; sustainable landscape applications; activity areas for cooking, entertaining, recreation or relaxation; environmental responsibility, maintenance requirements and durability; private or small gardens; rooftop gardens and more.

#### Criteria for Judging

- 1. Quality of design and execution
- 2. Design context
- 3. Innovative site-specific design techniques including green infrastructure and maintenance
- 4. Environmental sensitivity and community benefit through Low Impact Development (lid)
- 5. Design value to the client, the community, and other designers

#### RESIDENTIAL DESIGN (MULTI-FAMILY)

Professional entries in this category must be built. Recognizes construction of site-specific works of multi-family residential projects consisting of several units contained within one building or several buildings within one complex.

Typical entries may include high rise, multi-family new construction or renovations; historic preservation, restoration, or rehabilitation; senior or assisted living developments; residential condominium complexes; shared common areas for cooking, entertaining, recreation or relaxation; rooftop gardens and more.

- 3. Innovative site-specific design techniques including green infrastructure and maintenance
- 4. Environmental sensitivity and community benefit through Low Impact Development (lid)
- 5. Design value to the client, the community, and other designers

#### ANALYSIS AND PLANNING

Entries in this category do not have to be built or implemented.

Recognizes the wide variety of professional activities that lead to, guide or evaluate landscape architecture.

Typical entries may include urban, suburban, rural, or regional planning efforts; development guidelines; transportation planning, town planning, or campus planning; plans for recovery or reclamation of brownfield sites; environmental planning in relation to legislative policy initiatives or regulatory controls; cultural resource reports; cultural and natural resources protection, conservation, or historic preservation planning; and more.

- 1. Quality of analysis and planning effort
- 2. Context
- 3. Environmental sensitivity and sustainability
- 4. Likelihood of successful implementation
- 5. Opportunities for project to have a significant impact
- 6. Value to the client, the public and other designers



#### RESEARCH

Recognizes research that identifies and investigates challenges posed in landscape architecture, providing results that advance the body of knowledge for the profession.

Typical entries may include investigations into methods, techniques, or materials related to landscape architecture practice, studies of relationships of landscape architecture to laws, education, public health and safety, public policy, and more. Entries in this category should show the use of directed inquiry.

#### Criteria for Judging

- Clarity and importance of the research question, hypotheses, or goals
- 2. Significance of historical data and links to current knowledge
- 3. Appropriate research design and methods of inquiry
- 4. Clarity of presentation and outcome
- 5. Potential application to the practice of landscape architecture
- 6. Value to the field at large

# AWARD CATEGORIES


#### COMMUNICATION

Recognizes achievements in communicating landscape architecture works, techniques, technologies, history, or theory and the lesson value to an intended audience. This category includes published or written documents, multimedia, or electronic communications.

Typical entries may include books, articles, videos, films, audio recordings, podcasts, or exhibition design on landscape architecture projects, history, art or technology; educational material intended for the non-landscape architecture consumer; public awareness campaign for the profession, or environmental or conservation issues; and more.

#### Criteria for Judging

- 1. Effectiveness of message presentation
- 2. Innovation in approach or delivery
- 3. Value to the intended audience
- 4. Overall significance and relevance to the profession, the public or the environment.



#### STUDENT GENERAL DESIGN

Entries in this category are not required to be built.

Recognizes Graduate and Undergraduate students' site-specific works of landscape architecture.

Typical entries may include public, institutional or private landscapes of all kinds: urban design, streetscapes, transportation, and infrastructure design; commercial facilities; resorts; parks and recreational facilities; trails and open space planning; historic preservation, reclamation, or conservation; green roofs, storm water management, and sustainable design; landscape art and installation; and more.

- 1. Quality of design and design context
- 2. Environmental sensitivity and sustainability
- 3. Hazard mitigation, climate adaptations and resilience strategies
- 4. Design value to the client, community, and other designers.
- 5. Clarity of communication of design intent

Submittals to include all three (3) parts in one (1) .PDF file. Title the .PDF file name: RA-(name of nominee).

- Nomination Letter to include the name of the award you are submitting for, the name of the person or organization and their contact information, and a brief statement of why you believe they are award-worthy.
- Endorsements Provide a minimum of one (1) and up to three (3) statements of endorsement for your nominee.
- Nominee Acceptance Unless the nominee is selfnominating, provide a .PDF of either an email or dated letter of acknowledgment from the nominee that they accept the nomination.

#### MALAMA AINA AWARD

Recognizes individuals or organizations outside of the field of Landscape Architecture for distinctive efforts in promoting the preservation and enhancement of the landscape in Hawaii.

The nominee must be an ASLA Hawaii Chapter member in their first five years of practice making contributions in the profession to leadership, design, communication, and service.

#### **DISQUALIFICATIONS**

Materials in the submission must **NOT** reveal the names of the entrant and/or landscape architects, firms, other professionals, designers, contractors, photographers, student names, university, faculty advisers, or any other identifying information that would reveal the entrant. All project submittal information is to be anonymous. Entrant Identification is to be provided on separate entry forms only as directed on the Submission Forms online. Failure to follow this format will result in DISQUALIFICATION.

Failure to submit any section of the submittal, such as omission of the Project Statement, or less than a minimum of five (5) images, the entry shall be DISQUALIFIED.

ASLA Hawaii retains the right to disqualify any entry that does not meet the program requirements or that presents a conflict of interest.

Late Entries will not be accepted beyond the **Deadline 11:59 p.m. HST** on Friday, JULY 19<sup>th</sup>.

Entry Category – General Design (Public and Private), Residential (Single Family), Residential (Multi-Family), Analysis and Planning, Research and Communication, Student General Design

Project Title – Entries must have a short, specific presentation title that indicates the nature of the presentation.

Project Location - City, Island, State, Country

Project Statement – Brief Statement of **Why** this project is award-worthy. This statement may be used in promotional materials if the project is selected for an award.

Project Narrative – Describe in detail how it meets the criteria of the category. Include project site location, scope and size, site and context, design program, design intent, materials and installation methods, environmental impact concerns, collaboration with client, design team, and/or general community outreach, and any other significant details.

Project Images – All categories not less than five (5) images and no more than sixteen (16) total. General Design, Residential (Single-Family), Residential (Multi-Family), and Analysis and Planning, must include one (1) site plan. Label Images so that the Image Descriptions can be easily related to the Project Statement text provided. Labels to include the project title, brief caption, and image sequence number.
